Youth in Kerala involved in various HIV/AIDS awareness generation activities through Red Ribbon Clubs at college across the state.

To promote the right content among the youth Kerala State AIDS Control Society planned a short film competition for college students.

**Terms and Conditions** 

By participating in the competition, participants agree to be bound by, and are deemed to have read and understood these Terms and Conditions.

General Guidelines:

- 1. The competition is only for Indian Citizens.
- 2. Submission of the Short Film will start from 15<sup>th</sup> December, 2021 till 30<sup>th</sup> January, 2022.
- 3. Entry form and Consent Form are mandatory documents along with the short film. All entries for the competition should be submitted only through the email id :

<u>ksacs.shortfilmcomp@gmail.com.</u> An email stating that the entry has been received will be sent to every submission, if in case the contributor doesn't get a revert mail then S/He is requested to send the entry again.

- 4. The duration of short film should be more than 3 minutes.
- 5. The short film can be made on Malayalam or English.
- 6. English Subtitles are mandatory for all entries.
- 7. Animated films are also accepted for this competition.

- 8. The content of the short film should be associated with any of the below mentioned thematic areas (the detailed description on each thematic area is attached as separate document in the website):
  - I. HIV & Youth
  - II. Importance of Red ribbon Club
  - III. Importance of early diagnosis
  - IV. Condom Promotion
  - V. Stigma & Discrimination
  - VI. STI Prevention
  - VII. HIV/AIDS Act
  - VIII. National toll free number 1097
- 9. Film makers to work keeping the following outcomes in mind (one or more) :
  - Promote safe behavioural practices among youth.
  - Reduce stigma & discrimination associated with HIV/AIDS.
  - Motivate and sustain behaviour change in a cross section of identified populations at risk, including HRGs and bridge population.
  - Strengthen enabling environment for PLHIV.
  - Uptake of HIV testing and the stigma related to that.
  - Eliminate negative social norms which hamper the access to services.
  - Enhance awareness and knowledge levels of general population.

10. The film maker has to select one of the themes mentioned above for their short film.

- 11. Participant is to make sure that his/her profile is accurate and updated since SACS will be using for further communication. This includes details such as name, contact details and phone number. Entries with incomplete Entry form will not be considered.
- 12. Please note that the Short Film must be original and should not violate any provision of the Indian Copyright Act, 1957. The conceptualization should be original; Plagiarism will not be accepted. Any violation of this rule will lead to disqualification from the competition.
- 13. Anyone found infringing on others copyright will be disqualified from the Competition. NACO/SACS do not bear any re4sponsibility for copyright violations or infringements of intellectual property carried out by the participants.
- 14. All winning entries which receive prize or any other recognition as a result of participation in the short film competition will be intellectual property of the Kerala State AIDS Control Society (KSACS) and National AIDS Control Organization (NACO) and the winner cannot exercise any right over it.
- 15. The prize-winning short Film is meant to be used by NACO/KSACS for promotional and display purpose and also for any other use related to generating awareness as may be deemed appropriate for the initiative.
- 16. SACS reserves the right to cancel or amend all or any part of the competition and/or the Terms &Conditions/ Evaluation Criteria. However, any changes to the Terms & Conditions/ Evaluation Criteria, or cancellation of the competition, will be duly informed / updated.

- 17. By registering for participation in the competition, the Participant(s) warrant that :
  - i. They have compiled with these terms and conditions
  - ii. Their name is original
  - iii. Their entry does not infringe any intellectual Property Rights of any third party.
- 18. KSACS accepts no responsibility for any damage, loss or injury of any kind suffered by any participants in entering the Competition, including as a result of any participant winning or not winning any prize.
- 19. Entries must be made by the closing date and in the manner set out in the competition's Terms and Conditions. Failure to do so will result in disqualification.
- 20. Multiple submissions of entries by the same participant/college will also be considered.
- 21. The selected Top 07 entries will be awarded with cash Prizes and certificates :

1<sup>st</sup> Prize - Rs. 50,000/-

2<sup>nd</sup> Prize - Rs. 30,000/-

3<sup>rd</sup> Prize - Rs. 20,000/-

All other 4 consolation prizes – Rs. 10,000/- each.

22. The last date for the submission of entry is 30<sup>th</sup> January , 2022.
23. The selected entries will be uploaded on YouTube channel of KSACS & NACO and over various other communication platforms including social media in order to generate awareness.

24. The experts on Thematic areas, IEC division of KSACS and Film critic would comprise of the Panel of Jury and evaluate the competitors.

25. No financial support will be garnered from any brand in any manner whose products will be used in the film. Nor shall any specific brand be promoted with a/any promotional intent.

26. Technical details:

- i. Students will have to upload a copy of valid school/college/university ID card along with the entry.
- ii. The technical details of the Short Film with specific details as given below, to be the last frame of the submitted short film for the competition. These details will not be inclusive of the 3 minutes assigned for the short film competition.
