Sealed competitive Tenders are invited by the undersigned from the Agencies for the supply of Centrifuge to ICTC Centers . The specifications of the item mentioned in **Annexure I**

1. Quoted Price

- a. All duties, taxes, other levies, labour charges, installation charges & transportation charges payable by the bidder should be included in the item rate.
- b. The rate quoted for item will be fixed for the duration of the contract and shall not be subject to adjustments.
- c. Rates for partial quantity of an item is not acceptable;
- d. Corrections, if any, shall be made by crossing out, initialing, dating and rewriting.
- e. Telex and Facsimile or email tender are not acceptable.

2. Each bidder must submit only one tender.

3. Validity of tender

The tender shall remain valid for a period not less than 15 days after the deadline fixed for submission of tender or otherwise decided by the Project Director, Kerala State AIDS Control Society, Thiruvananthapuram – 35

4. Place & completion time

The work has to be completed within 15 days from the date of Work order as per the locations .

5. Special conditions

0.5% of the total amount quoted for each item will be deducted for each weeks delay, for the corresponding item, after the specified date.

6. Evaluation of tender

KSACS will evaluate and compare the tender determined to be substantially responsive ie: which

- a. are properly signed and
- b. conform to the terms and conditions and specifications
- c. the quotation would be evaluated for each work separately.
- d. The bidder who has quoted for the partial quantity of any one or more item(s) would be treated as non-responsive.

7. Award of contract

- a. KSACS will award the contract to the bidder whose tender has been determined to be substantially responsive and who has offered the lowest price.
- b. KSACS reserves the right at the time of awarding contract to increase or decrease the quantities, or award the work partly or jointly.
- c. KSACS prior to the expiration of the tender validity period will notify the bidder whose tender is accepted of the award of contract. **The terms of the accepted offer shall be incorporated in the Work order.**

- d. Payment will be made only after submitting the invoice in triplicate with necessary stock entry and installation report duly signed by the Officer in Charge or based on other valid documents as per existing Rules and Regulations.
